Payments and Funding

Unless otherwise specified, payment is due within 15 days of signing the contract. Payment can be made by cash, cheque, debit card or most major credit cards. Payment plans are also available to meet most budget requirements. Financing charges apply to payment plans. Beyond the allotted time, interest will be charged at a rate of 2% which is equivalent to 24% per annum (APR). When Prepaying, monies paid for services and supplies now will be used for the services and supplies when they are delivered at time of death. Trust: money can be paid directly to us and placed in a trust, where it will accrue interest until the contract is fulfilled (when services and supplies are delivered), or the contract is cancelled.

Refundable Deposit for Cremated Remains

When human remains are to be cremated, the payment of a refundable deposit to a maximum of \$350 may be required. If the cremated remains are not claimed within one year of cremation, the deposit can be used to inter the cremated remains in common ground. If the cremated remains are claimed before they are interred, the deposit will be refunded.
